Summary of Benefits for Short Term Disability Insurance
Effective 1/1/15

ELIGIBILITY:	All employees working a minimum of 20 regularly scheduled hours per week.
WAITING PERIOD FOR NEW EMPLOYEES:	You are eligible on your date of hire.
WEEKLY BENEFIT:	<p>After satisfying your Elimination Period, benefits will be paid at 100% of Basic Weekly Earnings for up to three weeks and at 66.7% for up to 22 weeks for a total of 25 weeks of medically approved disability.</p> <p>Benefits may be reduced by other income benefits received, such as California, New Jersey and New York State Disability, and Workers' Compensation</p>
ELIMINATION PERIOD:	7 consecutive calendar days for Injury or Sickness.
DEFINITION OF DISABILITY:	As a result of Injury or Sickness unable to perform the duties of your own occupation.
PARTIAL DISABILITY BENEFITS:	Partial disability benefits can be payable if your earnings are between 20% and 80% of your pre-disability earnings.
SUCCESSIVE DISABILITY:	<ul style="list-style-type: none"> • If you return to work for fewer than 15 consecutive days and are disabled again for the same or related cause, benefits can resume immediately. • If you return to work for fewer than 15 consecutive days and are disabled again for a different reason, the Elimination Period will apply. • If you return to work for 15 consecutive days or more, the Elimination Period will apply.
